It is the ultimate responsibility of the customer to ensure the safety of the final product (containing this fragrance) by further testing if needed.

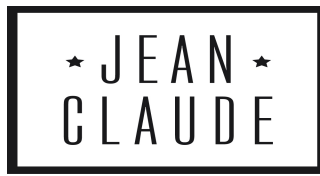
